### 5. Library Director's Report

Julia reviewed the Director's Report.

Checkouts are significantly lower than this time last year. E-Checkouts and Youth Non-Fiction checkouts are up. To help with check-outs will do some weeding, getting old books into catalog book river, new display ideas and may be able to add a third section of Afterschool Reading next fall which will bring in more patrons/check-out. However, it will take time to determine a trend with solid data post-pandemic closure. Julia will also reach out in the newsletter to see what people want to see that might increase physical check-outs. Jim suggested checking national trends.

### 6. Treasurer's Report

Val reviewed Treasurer's report and suggested the need for a finance meeting soon. We are running a deficit for July-Oct. this year but expect state monies soon after resolving issue with docu-sign. Experienced high investment gain in the month of October. Another round of the LEDA grant has been submitted. Confirmed that LANL Grant is a microgrant and should be used in accordance with the application request. Net income from Oktoberfest was \$1,759. Comcast has been reconciled. IRS 990 Tax Preparation is in process.

Val reviewed Fall Book Sale results. Revenue was \$8750.

End of the year appeal went out today and is up on our website; emphasizing Giving Tuesday. The appeal goal has been adjusted from \$15,000 to \$12,000.
