# 5. Library Director's Report

Checkouts have leveled out and are back on track. Not hearing back from county over junior money, will reach out to Matt again. Discussed need for process to pay out fundraising guests the day of event. The Blue Bus would like to have a stop here at the library and Julia is working out logistics with county- would need a couple dedicated parking spots- site visit is forthcoming.

The Board discussed McGarrity's offer to raffle off a book at Purple Fern bookstore event; but we have not heard back from bookstore proprietor. Gemma will go check in with her in person.

# 6. Treasurer's Report:

Nina reviewed budget to actuals. Financially we look good.

We are \$24,000 short for FY 24 proposed budget. Donna explained that the annualized

numbers process, grants and techs we won't receive, and single tech expense and bonuses create this disparity.

Julia suggested we could use a draw from the operating reserve to balance the budget but we are hoping to draw the whole materials budget (18k) from junior (SB 192) county money. We have a little over 76K in the operating reserves.

Nina strongly recommends that we reduce the number of categories and having a separate line for every total. Nina suggested moving some funds into a high yield short term CD and will look into this.

Dusty moved to approve FY 24 budget, Gemma seconded, motion approved.
